Secretary Krebs,

We have reviewed the purported Certification of Candidates submitted to your office by the South Dakota Democratic Party, which are available online on the Secretary of State's website. There are two separate forms submitted for a certification, one dated June 20, 2018 and received June 22, 2018 and one dated June 21, 2018 and received June 25, 2018.

These documents were not submitted in substantial compliance with SDCL 12-5-22. SDCL 12-5-22 requires that such a certification "shall be certified to the secretary of state by the officers of the convention, within three days of the close of the convention[.]"

Neither of the certifications received by your office are compliant with statute. The State Democratic Convention adjourned on the 16th of June. Under no circumstance would the certifications received on June 22nd or 25th be timely certifications under SDCL 12-5-22. In addition, they are not executed by any person in their capacity as an officer during the South Dakota Democratic Party Convention.

The Secretary of State's office is ministerial. The certification is plainly not in compliance with South Dakota law. This office does not have the discretion to ignore the plain language of statute, specifically mandated timeframes. The South Dakota Republican Party hereby demands that the Secretary of State not recognize the certification submitted by the State Democratic Party, and to not certify the candidacy of any candidate identified in said certifications.

Dear Ms. Tornberg,

Today our office received the enclosed letter. Based upon this letter, we re-examined the certifications of nominations which we received from the South Dakota Democratic Party and consulted again with the Attorney General's office concerning their prior advice in this matter which was to accept and file the certification. South Dakota Codified Law, section 12-5-22 provides that "[n]ominations by a state convention shall be made by a majority vote of the votes cast and shall be certified to the secretary of state **by the officers of the convention**, within three days of the close of the convention. No certification may be received by the secretary of state later than the second Tuesday in August."

The South Dakota Democratic Party convention ended on Saturday, June 16. Applying SDCL §§ 2-14-14 and 15-6-6(a), your certification was required to be made by the close of business on June 20, 2018. Our records indicate that your certification dated June 20, 2018, was not received by our office until June 22, 2018. Further, the mailed document was received by our office on June 25, 2018. As neither of these certifications was received by June 20, I must conclude the requirements of SDCL § 12-5-22 have not been met and the certification of candidates must be rejected.

For your candidates to be certified for the general election ballot you may, pursuant to SDCL § 12-15-17, give notice of another convention and resubmit your certification of nominations. Please be mindful of the statutory requirement that you provide notice to the Secretary of State's Office thirty days prior to that convention. Such convention must be held and the certification of nominations must be received by our office no later than 5:00 pm CT on August 14th pursuant to SDCL § 12-5-22.



Woody is registered as Woodrow Houser II, and is registered at 47267 300th St Beresford, SD 57004.


